

REQUISITIONING PROCEDURES

Prior to the purchase of any goods or services a requisition must be completed and forwarded to Business Manager or the Superintendent for approval. Following approval, the information on the requisition will be recorded on a purchase order and signed by the Purchasing Agent or Superintendent. The proper appropriation code number must be indicated on the purchase order to allow for encumbrance against the account.
