#### ABSENTEE BALLOTS FOR 2022-23 SCHOOL BUDGET VOTE

Applications for absentee ballots will be obtainable beginning April 28, 2022 between the hours of 8:00 a.m. and 3:00 p.m. Monday through Friday, except holidays, from the District Clerk. Completed applications for absentee ballots must be received by the District Clerk at least seven (7) days prior to the vote if the ballot is to be mailed to the voter, or the day before election, if the ballot is to be hand delivered personally to the voter. Absentee ballots must be received by the District Clerk no later than 5:00 p.m. on Monday, May 16, 2022.

A list of all persons to whom absentee ballots shall have been issued will be available in the office of the District Clerk from 8:00 a.m. until 3:00 p.m. prevailing time on each of the five days prior to the day of the election, except Sunday, May 15, 2022, and the day set for the election. Any qualified voter may challenge the acceptance of the ballot of any person on such list, by making his/her challenge and reasons therefore known to the Inspector of Election before the close of the polls.

This edition of Education Matters features a detailed summary of the proposed 2022-2023 budget and the school board candidates. The Annual Budget Hearing will be held Monday, May 9<sup>th</sup>, 2022 at 7:30 pm with this year's budget vote on Tuesday, May 17, 2022, 12:00 noon -9:00 p.m. in the Auditorium Atrium. If approved by voters, the district's total budget will be \$10,208,809.00 with a tax levy increase of 0%. In addition, Brandi Kerber and Kelly Button are running for the 5-year board seat.

As you know, it has been a year of challenges. The COVID-19 pandemic, related regulations, and subsequent ripple-effects have forced us all to exercise our patience, and also revealed the re-Springs Central School is to silient, empathetic and respectful character of provide a supportive and our school community. I am grateful for the performance of our teachers and staff, who provided a steady support system for our students. Unlike many other districts throughout the state and country, SSCS has remained open for our students, offering not just in-person instruction, but also an online option when students were DISTRICT OFFICE 518-284-2266 put into quarantine or isolation by the Department of Health. We had both the technological infrastructure and caring and well-prepared teachers to do so. We plan to maximize what we learned throughout this process and move forward to better engage and serve our students.

> Consistent with years past, our vision has been to prioritize developing a budget that maintains our tradition of strong core academic programs, meaningful electives and engaging extracurricular opportunities for students, while remaining fiscally responsible. The district, to every extent possible, continues to have a firm commitment to providing a broad range of positive experiences for our students by continuing to support field trips and extracurricular activities, including athletics and student leadership organizations such as FBLA and FFA. We also support students in pursuing vocational training, with students attending BOCES programs. Additionally, the

district is able to offer nine in-house University in the High School classes through collaborations with SUNY Cobleskill, SUNY Morrisville and Siena College. We believe firmly that each SSCS student should have opportunities to discover, develop and pursue success.

SSCS will continue to explore opportunities for collaborating and sharing costs with other districts, including transportation and special education programming, whenever possible. The district collaborates with other districts for professional development for teaching staff, regional summer school, spring sports and for collective purchasing and health insurance. The district has been sharing the cost of a School Psychologist with Jefferson Central School and will also continue to share our Technology Specialist with Schoharie Central School two days

As you may have learned through the recent series of public Board of Education meeting presentations, SSCS is excited to announce that our grant application was approved to use federal funds through the American Rescue Plan (ARP). As a result, over the course of the next several years, we will be building an outdoor learning space, expanding our agriculturaleducation with the addition of a greenhouse, and improving air quality in our elementary wing. We will also be continuing our literacy program, providing additional mathematics support and extending our mental health services. For additional improvements that coincide with the ARP-funded projects, we are asking for your support of a \$4.625 million project to replace roofs, expand the weight room to include space for OT/PT services, (...continued

additional improvement of air quality (2<sup>nd</sup> floor), asbestos tile removal, improvements to the existing girls soccer field, and other minor renovations throughout the building (e.g., toilet room on the 2<sup>nd</sup> floor and modernization of the special services area). This will be on the ballot as well as replacing one full size bus and one mini bus, maximum of \$185k. Please note that these projects will not only add value to our students' educational experiences but will maintain the long-term health of our school, and the funding of all these projects will be cost neutral (thus not impacting our local tax base).

Please vote on the annual school budget and board seat on Tuesday, May 17, 2022 between 12:00 noon - 9:00 p.m. in the Auditorium Atrium area. While we are able to return to an in person voting process this year, absentee ballots are available by contacting Katerina Bartlett or Lori Webb in the District Office.

Finally, and importantly, I would like to recognize and, on behalf of all of SSCS, offer my sincere gratitude for the current Board of Education President, James MacFadden. After 20 years of community-oriented leadership to Sharon Springs CSD (and the wider Sharon Springs Community) as a Board of Education member, Mr. MacFadden is passing the mantle. For two decades, Mr. MacFadden has brought a thoughtful, knowledgeable, detail-oriented, openminded and mission-driven approach in leading SSCS and ensuring that SSCS is responsive to the values, beliefs and priorities of our community. Mr. MacFadden's genuine, honest, and to-the-point leadership was grounded in his deep passion and commitment to our school-community, where he attended as a student, where he sent his two sons and where he located his very successful business. Mr. MacFadden's influence certainly travels deeply into what SSCS is and what it will always strive to be. Thank you!

#### What is ARP ESSER?

- The American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) Fund provided funds throughout the U.S in response to the impact of COVID-19.
- Through ARP ESSER, nearly \$9 billion was provided to New York State to "help safely return more of our students to inperson learning and maintain safe operations while meeting the academic, social, emotional, and mental health needs of students resulting from the Coronavirus 2019 (COVID-19) pandemic."
- Funds are divided among other school districts statewide based on enrollment.
- ASP ESSER funds can be used for the following key aspects: Health and Safety, Facilities, Nutrition, Transportation, Social Emotional Well-being, School Schedules, Budget and Finances, Attendance and Chronic Absenteeism, Technology and Connectivity, Teaching and Learning, Special Education, Bilingual Education and World Languages and/or Staffing and Human Resources.
- Funds are available for a limited time.
- School districts that do not act within the allotted time will lose eligibility for funds.

#### PROPOSED ARP Projects in Combination with Proposed Capital Improvement Project

Over the past several months, you may have heard about the proposed building projects that have been presented at our Board of Education Meetings. The School Board was very thorough in evaluating the needs of the district. Essentially, the project calls for renovations throughout the school.

Preliminary items include:

#### **American Rescue Plan Projects**


- Outdoor Classroom "Pavilion" (adjacent to existing playground)
- Greenhouse (adjacent to Ag/Tech Area)
- Updated Elementary School Ventilation


#### **Proposed Capital Projects**


- Roof Replacement
- Soccer Field Reconstruction (Increased Drainage, Regulation Sized Field, and Safer Playing Conditions)
- Physical Therapy Expansion (Expand the Weight Room Area to include a PT/ OT area)
- Toilet Room Added to the Second Floor
- Third Floor Improvements (Improved Special Education spaces)
- Elementary School Abatement

The Board understands the community's desire to find the right balance between support for our schools and the cost to taxpayers. It is expected that there will be no tax increase for these projects. We plan to combine the ARP aid with the available NYS regular building aid reimbursement the district receives. Interest earned through the temporary investment of the project funds results in no additional tax dollars needed.

To receive funding, a capital project must be approved by voters, with the primary purpose of the funds having to comply with one of five categories: Health and Safety, Accessibility, Physical Capacity Expansion, Energy, or Educational Technology.
