

Requests for APPR Scores

All parents/guardians now have the right to request Annual Professional Performance Review (APPR) quality ratings and composite effectiveness scores for their child's current year's teacher(s) and principal.

To obtain scores, parents/guardians must first submit an official request form, available below. However, please be aware of the following instructions for the request form:

1. The form must be completed, in its entirety. Incomplete forms will not be processed.
2. Once complete, please return the form to the Superintendent's office.
3. All requests must have a photocopy of the requester's photo identification (i.e. driver's license, passport, etc.). Forms submitted without a copy of a photo ID will not be processed.
4. Please address any questions or concerns directly to Mr. Yorke or Mrs. Webb at 284-2266 X100.

Once the completed form has been received and school personnel have verified the request is valid in accordance with state law, you will be contacted to set up a meeting with the superintendent to receive the requested score(s).

Meetings will be scheduled at the start of the school year.

PLEASE NOTE:

- The teacher(s) and/or principal for whom scores are requested must be the teacher(s)/principal of record for your child in the 2023-2024 school year.
- The law requires districts to "verify that any such request is a bona fide request by a parent or guardian entitled to review and receive such data." This is the reason photo identification must accompany forms.
- An appeal of the APPR by the teacher/principal will delay providing this information until such time as the appeal is concluded.
